These products meet all American approval requirements and fully comply with the FCC and RTCM standards. Even if the unit falls to acquire a GPS position, the product will still transmit a distress alert within 3 minutes to the GEO-Stationary subclittes for onward transmission to the reacue authorities.

We do not understand why our products performed as reported in these trials. The ERIRBs and PLBs used were tested pre-trial and obtained GPS lock within two to three minutes. All beacons, manufactured by McMurdo, are tested for GPS lock before they leave the factory. When independently lested elsewhere in the United States, Europe and Australia, the same products achieved GPS ecquisition superior to that experienced in these trials.

A key element to understanding why our products performed as reported will be to undertake a detailed analysis of the tested beacons. We have requested the return of the beacons used in these trials however. to date, we have been unable to obtain them.

McMurdo understands that consumers may be concerned with the implications of these results. Our primary objective is to reassure you that our commitment to consumer safety remains paramount.

in response to these unexpected results, we will be commissioning further independent trials. This will verify current product performance and ensure these products most McMurdo's high performance standards. The results of these independent tests will be widely communicated at the earliest opportunity and a further statement issued
