

Manufacturer's Bulletin

Recent reports and magazine articles regarding the GPS performance of two McMurdo products have apparently created some consumer confusion and concern. We are now contacting you to clarify the situation and help answer some of the questions that may be asked by your customers. The two products referred to are:

Precision 406 GPS EPIRB (manual & automatic release)
FastFind Plus PLB (with GPS)

No other MaiMurdo or Pains Wessex products were involved.

Firstly, both of these products meet all current US approval specifications and fully comply with the FCC and RTCM standards.

As stated in previous consumer correspondence it is our intention to carry out our own tests, witnessed by an internationally abknowledged independent witness. All beacons manufactured by McMurdo are tested for GPS lock before they leave the factory. The beacons used in these tests were re-programmed to test protocols prior to the trials, again tested and obtained GPS lock within two to three minutes. When independently tested elsewhere in the United States, Europe and Australia, the same products achieved GPS acquisition superior to that reported in these trials.

Regiletion of the tests on the PLB's has commenced and we can confirm that the results recorded so far outperformed those reported. At this time we also tested the latest version of software and firmware available and showed a marked improvement in speed of GPS acquisition. Teeting of the EPIRB's is due to take place during week commencing June 28", where we shall also test the software and firmware enhancements. A full report of this testing will be available upon completion of the testing and collation of the data.

However McMurdo understands that consumers may be concerned with the implications of the reported test results and our primary objective is to reassure them that our commitment to their safety remains paramount.

As a responsible and reputable manufacturer we take extremely seriously any concern customers may have regarding our products. As a result, we are offering consumers the opportunity to return their beacon to our US service center for a free full diagnostic test and software and firmware upgrade.

We have already commenced the upgrade program for the FastFind Plus PLB. The upgrade program for EPIRB's will follow upon completion of the testing and receipt of the results and subsequently we are aiming to commence the Precision upgrade program by the end of July or certy in August.

We also confirm that all new orders shipped from Revero Supply will be the new enhanced product. Revero Supply in Jacksonville will be contacting you directly regarding exchanging any inventory you currently have in stock for the new enhanced beacons.
